Referees

- (a) Each delegation must be accompanied by an International or a Continental Referee (IJF "A" or "B").
- (b) The national federations are responsible for their referees' travel and accommodation expenses.

Official Expenses

The AJU is responsible for the travel expenses of its Official members while the Organizing Committee is responsible for the expenses of their accommodation and domestic transportations.

Insurance

- The South African Judo Federation has no responsibility in the matter of insurance.
- Each national Federation shall take all necessary steps to provide insurance coverage against civil liability and illness for all the members of their delegation during the championships.

Accommodation

The prices of accommodation are as follow:

Chiefs of delegations and Presidents of Federations:

Single room : 110 euros per person and per night in ½ pension
Double room:90 Euros per person and per night in ½ pension

Referee :

Single room : 80 Euros per person and per night, complete pension
Double room 60 Euros per person and per night (2 bed one place), complete pension

Athletes, Coaches medical :

Single room : 80 Euros par personne et per night), complete pension.
Double room: 60 Euros per person and per night (2 beds one place), complete pension

All personal consumptions: drinks, bar, telephone etc.... are considered like extra and paid by the consumer.

All National Federations are responsible for the meals and accommodation expenses of all the members of their delegations which shall be paid to the organizing committee upon arrival.

Domestic Transport

The Organizing Committee will provide local transport from the airport to the hotels and to training and competition venues in Agadir.

Draw, Weigh- in & Judogi Control

- The Technical meeting and draw will take place on Tuesday, 14th May 2008 at 8.00 pm in the official hotel according to the rules of the IJF.
- Only two (2) representatives of each participating country are allowed to attend the Technical meeting and the Draw. The I.D. card and official documents of each athlete will be presented
- The Weigh in will take place in the hotel in the morning of each contest day according to the official schedule and according to the IJF Technical rules.
- The duration of each contest shall be 5 minutes for both men and women, according to the IJF rules.
- All the delegations shall submit the judogis of their athletes to the judogi control upon arrival at the hotel in order to regulate them and the country codes or the advertisements, according to the IJF rules. The athletes must each bring white **and** blue judogis.

Nationality

Proof of the Nationality of the athletes shall be by the production of official travel documents from the country of each athlete and the athlete's ID card will be made accordingly.

Anti-doping Control

The anti-doping measures will be analyzed in the approved anti-doping laboratories according to the IJF rules.

Training

A schedule is being prepared to make use of training halls in order to provide equal opportunities for all teams to be trained and it will be submitted to all teams upon arrival.

Important Instructions

- 1- Only the member countries of the AJU who have paid the annual subscription fees regularly until the year 2008 can participate in this Championship.
- 2- Each delegation is requested to bring their national flag (120 cm x 180 cm) and a recorded short version of the national anthem on a cassette tape.

Visas

The countries whose nationals are required to have a visa for entry to Morocco (to ascertain this, they should approach their ministries of Foreign Affairs) are requested to apply at the Moroccan embassy in their countries. Failing this, they may contact Moroccan Judo Federation and provide the information required by immigration control in order to guarantee obtaining visas on their arrival to Morocco.
